

TERMS OF USE

1. WHO WE ARE

We are a registered charity (charity no 1116375) and registered company (company no 05860929) in England and Wales and have our registered office at 22 Lavender Hill, London, SW11 5RN, UK. We are regulated by the [Charity Commission](#).

2. ACCEPTANCE OF THESE TERMS

By using our site, you confirm that you accept these Terms of Use and that you agree to comply with them.
